1. Bench - The previous Clerk had not received any reply from Natural Resources Wales in relation to the damage caused to the concrete slab for the bench. Another e-mail was sent to Natural Resources Wales. An automated reply was received stating that they would look into the matter.

A reply was received from Natural Resource Wales (NRW) stating that they were unaware that there was a bench situated at the location. They stated, more than likely, the damage to the concrete slab had been caused by their machines and they were happy to work with the Council to replace the bench. They did request if it was possible to move the bench slightly allowing access to the area for their machines. It was decided that the Clerk, Councillors B. John and A. Thomas would meet to look at a new location for the bench. It was agreed that the bench could be moved. Dyweddod y Cynghorydd Sir, H. Jones: -

County Councillor H. Jones stated: -

1. Fod y Cyngor yn dal i edrych mewn l'r :- Garafan tu ôl i'r Temple Bar,
Garafan yn y coed ger fferm Pantyllyn, a'r Stablau gogyfer ag Abercamlais (Gorchymyn Gorfodaeth)

1. That the Council were still looking into the :- Caravan behind Temple Bar,
Caravan by Pantyllyn Farm, and Stables opposite Abercamlais (Enforcement Order)

2. Dŵr yn gorlifo yn Milo (rhwng y capel a Dildre) – mae'n amlwg bod yna broblem gyda dŵr ar wyneb yr heol mewn cyfnodau o law trwm. Mae hyn wedi achosi llifogydd mewn eiddo preifat. Rhan gyntaf y broblem yw nad yw'r dŵr yn cael ei droi i'r gwteri cyfagos. Oherwydd hyn, mae'r dŵr ar wyneb yr heol am gryn bellter. Gall hyn achosi broblem beryglus os fydd hi'n rhewi yn dilyn glaw (ac nid oes bin halen gerllaw chwaith). Cynghorydd Sir, H. Jones i ofyn i'r adran berthnasol am gyfarfod ynglyn ar mater hyn.

2. Water overflowing in Milo (between the chapel and Dildre) – it is obvious that there is a problem with surface water during periods of heavy rain. This has caused flooding in private houses. Part of the problem is that the water is not being diverted to the nearby drains. Due to this water is on the road for some distance and this could be dangerous should it freeze following a period of rain. (There is no grit bin nearby). County Councillor H. Jones will ask for a meeting with the relevant department.

3. Ysgol Nantgroes. Mae rhai o drigolion yr ardal wedi cysylltu yn crybwyll y dylid gofyn i ddatblygwyr y safle i ganiatau doddi cofeb i'r ysgol ar y safle.
