A reply was received from Natural Resource Wales (NRW) stating that they were unaware that there was a bench situated at the location. They stated, more than likely, the damage to the concrete slab had been caused by their machines and they were happy to work with the Council to replace the bench. They did request if it was possible to move the bench slightly allowing access to the area for their machines. It was decided that the Clerk, Councillors B. John and A. Thomas would meet to look at a new location for the bench. It was agreed that the bench could be moved. The Clerk met with Rebecca Thomas of NRW who stated that they wanted to place an information board some 50m from the roadside and requested that, if possible, that the bench be placed by this board.
